

NOTICE OF PROJECT PLANNING PUBLIC MEETING

The Oakland County Water Resources Commissioner's Office (WRC) will hold a public meeting to discuss two (2) new Clean Water State Revolving Fund projects for the purpose of receiving comments from interested persons. A total of fifteen (15) projects are included in the FY 2024 Oakland County Water Resources Commissioner's Office State Revolving Fund Project Plan. The additional thirteen (13) projects have not changed from the last plan submittal.

The meeting will be held at 2:00 p.m. on April 25, 2023 at the WRC Office (One Public Works Drive, Building 95 W, Waterford, MI 48328) and via Teams Videoconference:

The purpose of the proposed project plan is to secure low interest funding for nonpoint source water quality treatment improvements. The projects described in the project plan will help reduce the amount of stormwater, reduce stormwater pollutants, reduce erosion, and attenuate flow to drains by retaining, detaining, and infiltrating stormwater runoff. Two (2) new projects were added to the project plan, but all project locations can be viewed at: www.oakgov.com/water

Project construction for the new projects will include wetland creations and water quality improvements through native plantings and infiltration basins. Impacts of the new projects include improving water quality and reducing stormwater runoff with temporary construction impacts such as minor traffic disruptions.

The new projects will be funded by low interest loans from Michigan's Clean Water State Revolving Fund. The County's entire project plan has a combined estimated construction cost of \$25,347,900 with the two (2) new projects estimated to be \$853,600 and \$491,100. Apportionments will be consistent with the requirements of the Drain Code of 1956.
